**POLICY TITLE: Honorarium and Council Per Diem
Compensation**

POLICY NUMBER: 11-001

POLICY PURPOSE:

To establish the recipients of, and circumstances of payment of honorariums and loss of earnings.

POLICY:

1. Members of Council will be paid a monthly base stipend. The Mayor shall receive \$ 2329.00 per month and each Councillor shall receive \$ 1101.00 per month.
2. Members of Council may submit a claim to receive a Meeting Honorarium for attending meetings outside the Town of Swan Hills:
 - a. Meeting of Council or Council Committees with other municipalities.
 - b. All other meetings that are pre-approved by Council either by appointment to the out-of-town board or by a motion of council.
 - c. AUMA Convention.
3. Half-day compensation, equal to or less than four hours' time commitment is \$ 92.00.
Full-day compensation, more than four hours' time commitment, is \$160.00.
4. Council members that are required to attend meetings outside the Town that supply their own transportation or the transportation of other members, may submit a claim based on the distance traveled.
5. Travel will be reimbursed at a rate per kilometre matching the yearly automobile allowance rate set forth by the Canada Revenue Agency.
6. Compensation for meals and lodging away from Town shall be reimbursed based upon receipts.
